7:02PM The Budget Hearing for FY26 opened, there were no comments from community, Leinbaugh reported that she did not receive any comments regarding the hearing. The budget hearing was closed at 7:06PM.

Shae Leinbaugh was sworn in by Mayor Todd Bengford as new City Clerk.

Resolution 25.39, A resolution to adopting the FY2026l budget was introduced with motion to approve by Hemer, seconded by Stuhrenberg. Roll call ayes: Hemer, Duff, Stuhrenberg, Thies, Sorensen.

Tear down of 203 S. Main St was discussed and decided that the city was going to move forward with the tear down. Thies made the motion and Duff seconded it. Roll call ayes: Hemer, Duff, Stuhrenberg, Thies, Sorensen.

Motion by Hemer and seconded by Thies to approve contract with Service Master to complete some cleaning and mold control at city hall at a cost of \$1972.80. Roll call ayes: Hemer, Duff, Stuhrenberg, Thies, Sorensen.

City Hall discussion was tabled until a future meeting.

Replacement of flags in the Memorial Circle and Heritage Square were discussed and council instructed Clerk to reach out to the Odebolt Betterment Committee to see if they had a budget for maintenance of the flags.

Council decided that livestock including ducks are not allowed within city limits. This item will be addressed in the recodification process the city is already working on.

Snow Plow damage done to the Curb at 724 W. 4th street was reviewed. Public works will attempt to correct damages from the snow plow.

County Law Enforcement Report were available, Ken McClure was present and discussed parking tickets during the winter months.

2024 Bridge Inspection was reviewed and the bridge located on Willow Street was discussed. This bridge is the next on the list to be worked on and a few different options were brought up on how to proceed.

Supt of Public Works Report: It is that time of year to be planning what projects we wanted to be focusing on this spring/summer. Quotes for work on Mandernach Dr and patching the streets. Public works will be renting an excavator to do some minor street and storm water work as allowed by budget and get pricing from the previous year's contractor. Mayor will reach out to Landus regarding the deteriorating gravel around the railroad tracks and road.

Committee Report: Hemer reported that a resident is having sewer problems from the city flushing and backwashing the filters at the water plant. Council had previously decided on a solution and is going to move forward with fixing it.
